 Members had an opportunity to ask questions on work accomplished since October 26, 2018. Members also discussed the upcoming 100 year anniversary of women beginning to obtain the right to vote in New Brunswick and the importance of public education that frames the date in an intersectional way.

 Minister Wilson addressed the membership and answered questions and discussed various issues, including: the 211 model of program/service navigation; midwifery; the use of a gender lens on the provincial budget; housing services; and mental health. Minister Wilson requested that the council prepare and submitted a revised proposed budget for 2019-2020 that included a reduction.
